## II. Privacy Policy

The operator is responsible for the collection, processing and use of your personal data within the meaning of the German Data Privacy Act (BDSG) and the German Telemedia Act (TMG). The operator has implemented numerous technical and organisational measures to ensure the most complete protection of personal data processed through this website. ### A. Scope and purpose of the collection, processing and use of personal data when visiting this website

With every visit to this website there is information being stored temporarily in so called log-files (access-log, error-log) that are saved on the hosting server (provider: HostEurope). The following data is automatically recorded without any action on your part and stored for a period of six months: -Date and time of access, -Name and URL of the accessed file, -Operating system of your computer and the browser that you use, -IP address. This data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. The data will be deleted automatically after a period of six months. In addition, there are also cookies created during visiting this site. ### B. Transfer of Data to Third Parties
