## II. Privacy Policy

The operator is responsible for the collection, processing and use of your personal data within the meaning of the German Data Privacy Act (BDSG) and the German Telemedia Act (TMG). ### A. Scope and purpose of the collection, processing and use of personal data when visiting this website

The following data is automatically recorded without any action on your part and stored for a period of six months:

- Date and time of access,
- Name and URL of the accessed file,

- IP address.

is data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. The data will be deleted automatically after a period of six months.

### B. Transfer of Data to Third Parties

There will be no transfer of personal data to third parties until the user has expressly agreed to this or if the operator will be under a legal obligation to do so. Transfer to third parties for other purposes will not take place.

## C. Right to Information, Correction, Blocking and Deletion
