II. Privacy Policy

This page explains how and when your personal data is collected, processed and used when accessing hardmood.info or any of its subdomains. Basis of all processing are the terms of the General Data Protection Regulation (GDPR).

This data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. B. Transfer of Data to Third Parties
