## **II. Privacy Policy**

This page explains how and when your personal data is collected, processed and used when accessing hardmood.info or any of its subdomains. Basis of all processing are the terms of the General Data Protection Regulation (GDPR).

The operator is responsible for the collection, processing and use of your personal data within the meaning of the (GDPR) German Data Privacy Act (BDSG) and the German Telemedia Act (TMG).
